**Y9 Field Trip to Kuşadası, Efes and Pamukkale.  
Monday 3rd October to Friday 7th October 2016  
4 nights, 5 days – 500TL**

A field trip has been planned from **Monday 3rd October to Friday 7th October to Kuşadası**, a coastal resort town in the Aydın Province of Aegean Turkey. It is quite simply a beautiful part of the country, located approximately 570 kilometres from Istanbul, and is a stopping- point for many of Turkey's better classical ruins.

This trip is for Year 9 students and it is expected that all students take part. The school will subsidise field trips, but a parental contribution of **500TL** per student is requested to cover costs. We will be using the tour company, POS Turizm, the same company we have used for other secondary field and ski trips. The hotel we will be staying at is the **Batihhan Beach Resort in Kuşadası**, which is rated four stars and is a perfect match for our needs. Students will be staying in quality rooms of three sharing. Each room is equipped with essential facilities. Alcohol, if any in minibars, will obviously be removed before students enter rooms. Our all-inclusive deal offers a superb selection of food that, I am sure, will cater for all our dietary needs. There is much to do at this family-centred hotel resort; any downtime the students have can be filled in a number of rewarding and entertaining ways.
